The DS-260 application can be submitted only online, and only after you have paid your required visa processing fees. There may be a few days' delay between the time you pay your fees and when you will be allowed to access the form.

DS-260 filing tips. To begin, you'll need your case number, beneficiary ID number, and invoice number from the original welcome notice that the NVC sent you. The entire DS-260 online form must be filled out in English. If you are submitting addresses or names that aren't in the Roman alphabet, you must transliterate them.
