If you intend to ship hazardous materials (aka. Dangerous Goods), either domestically (within the US) or internationally by air, you will likely be required to comply with the IATA DGR. A challenge to compliance is that it is updated annually; therefore the 54th Edition, in use in 2013, is no longer acceptable for compliance in 2014.
